

# A THEOLOGY OF COVID-19 VACCINES

(August 12, 2021)

## America's Black Robe Regiment

We are each individually responsible to God for the things done in our body. "The naive believes everything, but the sensible person considers his steps." Proverbs 14:15 (NASB).

### I. Experimental Gene Therapy.

God created man in his own image: in the image of God, he created them male and female. Genesis 1:26-27. God created every "kind" to procreate after its own "kind." Genesis 1:11, 12, 21, 24, 25. He specifically proscribes the mixing of kinds. Leviticus 19:19; Deuteronomy 22:9.

Prior to the COVID-19 vaccine, all vaccines employed weakened (attenuated) or dead pathogens (*e.g.*, viruses) to trigger an immune response that could later fend off an exposure to the live virus, except for the hepatitis B vaccine which is produced from a recombinant surface antigen of that virus. The three COVID-19 vaccines approved for emergency use in the United States (Johnson & Johnson, Moderna, and Pfizer) use experimental gene therapy --- outside of the traditional definition of a vaccine. Indeed, some definitions of vaccine has now been altered to include gene therapy, to afford vaccine manufacturers protection from liability and to facilitate the imposition of this novel, untested medical intervention on the people.

These vaccines use a totally new and exotic technology that utilizes cutting edge nanotechnology to introduce into our bodies lipid platforms (*i.e.*, "lipid nanoparticles") or virus-delivery systems (*e.g.*, adenovirus, as is the case with the Johnson & Johnson vaccine) for the purpose of bypassing the innate immune systems that God gave us so that the vaccines contain genetic instructions to produce the SARS CoV-2 spike protein to gain entry into the recipient's nucleus and therein alter the DNA. The mRNA vaccines can permanently alter our inherently fixed and stable human genetic code in such a way that these changes are irrevocable and produce lasting harm to potentially every cell in the body. From the published and peer-reviewed scientific data published thus far, it can be concluded the vaccines will inflict widespread damage to those who receive them, whether intentionally or not,

### II. Use of Aborted Fetal Tissue.

Life begins at conception. Therefore, fetal cell tissue use during any phase in the manufacture, production, and administration of COVID-19 injections is immoral and unjustifiable. On its website, the [Institute for Clinical Systems Improvement](#) (ICSI) in Bloomington, Minnesota states:

*mRNA COVID-19 vaccines do not contain any aborted fetal cells. Fetal cell lines are not the same as fetal tissue. Fetal cell lines are cells that grow in a laboratory. They descend from cells taken from elective abortions in the 1970s and 1980s. Those individual cells from the 1970s and 1980s have since multiplied*

*into many new cells over the past four or five decades, creating fetal cell lines. **Current fetal cell lines are thousands of generations removed from the original fetal tissue.***

*In the Pfizer-BioNTech and Moderna vaccines, no fetal cell lines were used to produce or manufacture the vaccine, and they are not inside the injection you receive from your doctor/nurse. **Fetal cells may have been used to test efficacy and/or proof of concept** (see sources below).*

***The Johnson and Johnson vaccine did use fetal cell cultures, specifically PER.C6 (a retinal cell line that was isolated from a terminated fetus in 1985), in order to produce and manufacture the vaccine.***

Let’s be clear: fetal cell lines would not exist if it weren’t for fetal tissue harvested as a result of abortion. Whether the fetal cell lines are now grown in cultures, test tubes, petri dishes, or in incubators, they began as life in the womb.

“Before I formed you in the womb I knew you.” Jeremiah 1:5 (NASB). The thinly veiled excuse that the fetal cells that once belonged to the body of a soul that came from and belongs to God cannot disguise the human blood that stains the creation of SARS CoV-2 in the Wuhan Institute of Virology, research that was supported with the help and funding of the National Institutes of Health and major academic institutions. Without abortions there would be no fetal tissue, no fetal cell lines, through gain of function studies of the bioengineered SARS CoV-2 virus in “humanized mice,” and no COVID pandemic. Abortion and its manufactured byproducts are integral to the development of vaccines and their manufacture. The Bible forbids the shedding of innocent blood, a crime for which the wrath of God is visited from heaven on all who participate in or benefit from the crime of murder, bloodguilt that cannot be cleansed but by the blood of the murderer, and if not dealt with, eventually the quartering community.

The word of God is unambiguous: “So ye shall not pollute the land wherein ye are: for blood it defileth the land: and the land cannot be cleansed of the blood that is shed therein, but by the blood of him that shed it.” Numbers 35:33 (KJV).

### **III. Attempts to Manipulate Through Fear and Deception.**

“For God hath not given us a spirit of fear; but of power, and of love, and of a sound mind.” 2 Timothy 1:7. When you discern you are being motivated by induced fear, you have a signal that you are on the verge of making the wrong decision. The vaccines have been aggressively marketed to the American people using fear. Some have threatened, if you do not

take the vaccine, the shutdowns will continue. Or, if you refuse, you will kill people around you. Since the COVID-19 vaccine never promised to give “sterilizing immunity” so that the recipient could not get the virus, a vaccinated person can get and spread the virus. The effort to use deception and fear is clear.

“A prudent person sees evil *and* hides himself; *But* the naive proceed, *and* pay the penalty.” Proverbs 27:12 (NASB). Therefore, Christians are to be watchful and discerning about risks and dangers. While some may disagree with these conclusions, we believe them to be compelling indications that the vaccine is neither safe nor effective.

- Copious evidence (including VAERS data) has shown that all COVID-19 vaccines are, in fact, designed to be dangerous and life-altering.
- Vaccines have not undergone adequate testing. Based on all available data, there is no question that these vaccines have resulted in more injuries and death than any other “vaccine” in human history – far more than the SARS CoV-2 virus.
- The entire medical industry has adamantly advanced the notion that all vaccines, as approved by the FDA, are “safe and effective.” This is patently not the case, as any parent of a vaccine-injured child can attest. Holy Scripture declares that “A lying tongue hateth those that are afflicted by it; and a flattering mouth worketh ruin.” Proverbs 26:28 (KJV). Scripture teaches: “let God be true, but every man a liar.” Romans 3:4 (KJV).

The large and expanding number of cases of injury and death directly attributable to the COVID vaccines do not in any way support the premise that they are safe. Indeed, compared to the generally accepted and proven overall mortality rate of a SARS CoV-2 infection of 1 percent, there is ample evidence that the COVID vaccines, taken as a whole, are a much greater threat to the health and wellbeing of the 7.2 billion souls on Earth.

- To smother any reasonable doubts about the safety or efficacy, the government has come out in force to censor anything, any study, any opinion, and anyone who challenges the wisdom of promoting or, worse, mandating the use of these vaccines at the present time. Nonetheless, God’s truth prevails, as it always does. Satan has always been the father of all lies, and social media and societal pressure are now his favorite platforms. John 8:44.
- The Greek word from which we get the word pharmaceutical is translated in Scripture as “witchcraft” (Galatians 5:20) and “sorceries” (Revelation 18:23). At least in the case of the COVID vaccines, this is a warning sign that raises legitimate concerns on the part of Christians and the general public.
- A warning sign is the wholesale indemnification of vaccine manufacturers against any liability related to the COVID vaccines, combined with reports that some health insurers have denied payment for vaccine injuries specifically because they are “investigational” and have not been fully approved by the FDA.

The Bible teaches that not everything held to be true, even if touted as “science” or common “knowledge” stands up to scrutiny. Human history is replete with examples of beliefs that once were taken as “gospel,” yet today are the stuff of coffee table humor. There was a time that washing hands after an autopsy and before delivering a baby was considered unnecessary. During the 1700s, “tobacco smoke enemas” were used to treat a range of conditions, including headaches, stomach cramps, and even death, which may have led to the colloquialism “blowing smoke up your ass.” George Washington’s death followed bloodletting – the medical state of the art at the time. In writing to Timothy, Paul warned his young protégé to avoid opposition based on the “knowledge” or “science” of this world, “[w]hich some professing [had] erred concerning the faith.” I Timothy 6:20-21 (KJV).

Emerging news and data indicate risk to be greatest for damage to the blood, endothelium, and heart, and evidence is now emerging that the spike protein aggregates in the bone marrow. The bone marrow is the cradle of the blood. It contains the stem cells which differentiate to form the healthy complex of blood cells that make the body thrive.

#### **IV. Personal Responsibility for Our Decisions.**

As Christians, we – including our bodies – belong to the Lord. Our bodies do not belong to the state, or to any man, or to any employer. 1 Peter 2:9; 1 Corinthians 6:19, 20; 1 Corinthians 7:23. Any attempt to alter, damage, or destroy the image of God in man is an insult to our Creator and rebellion against God. The Greek verb translated destroy (phtheirei) in Romans 9:20 also means “to corrupt” or “spoil.”

Christians and their bodies are described as the temple of God, and the Spirit of God dwells within us. 1 Corinthians 6:18. While the context of that verse is sexual immorality, this signifies to us that we must be careful how we use and treat our bodies.

Every person is responsible for acts done in his or her body. Responsibility to God for one’s own actions is not obviated by government or private party demands to disobey God’s Word. No temporal crisis, calamity, disease, or pandemic obviates the will of God or nullifies one of his commandments. Whenever civil law contravenes the revealed will of God, we must and will obey God rather than men. Acts 5:27-29 (KJV).
